Clinic

Clinics are held **twice a month on Wednesday evenings, between 5:00 PM and 7:30 PM**. Volunteer lawyers are scheduled on a rotation, based on monthly availability. Each clinic consists of pre-scheduled, 30-minute, summary advice appointments with individual artists or arts organizations. Lawyers provide summary advice and write a brief summary of the advice given.

NOTE: To provide summary advice, lawyers must be **called to the Bar for at least 3 year and have at least 2 years of relevant experience** in arts, entertainment, business or intellectual property law.

Workshops and ALO Events

The ALO encourages dialogue between the legal and artistic communities through workshops, forums, and conferences. Lawyers can help out in a variety of areas, including legal research and writing; speaking; event planning; marketing; and fundraising.
