Email Newsletter and Media Release Broadcast

The Alliance for Arts and Culture publishes a weekly digital newsletter, **Alliance News**, as well as **mediaNET**, a weekly email broadcast of event media releases to more than 500 Metro Vancouver media contacts.

The **Alliance News** is a weekly email newsletter with information for and about the Alliance and its members. It includes announcements of grant and other funding opportunities, links to members' event announcements, advocacy alerts, and other news and information of interest to the Metro Vancouver artistic, cultural and heritage community and related industries.

mediaNET is a weekly broadcast to more than 500 Metro Vancouver print, broadcast and online media outlets. Members are charged \$45 for the first page and \$20 per additional page. Non-members pay \$75 for the first page and \$40 per additional page. For an additional fee the Alliance's communications department can provide a current media contact list and some useful tips on pitching your event to key media managers. All prices include applicable taxes.
